KeyHIE is now a registered business in the State of New Jersey! We look forward to furthering our mission of providing the right information at the right time to improve the lives of the patients we serve. Stay tuned for more information to come!

KeyHIE is excited to announce that we will now be working to form a connection with the Chesapeake Regional Information System for our Patients (CRISP). CRISP is a non-profit regional health information exchange, serving Maryland and the District of Columbia. CRISP has also received a designation from the Maryland Health Care Commission as the official statewide health information exchange for Maryland.





The VA's Veterans Health Information Exchange (VHIE) will have the following three major changes in 2019, affecting all query-based exchange partners, including KeyHIE:

- As part of the Mission Act, the VA will transition to an informed Opt-Out model, where signed authorization will no longer be required prior to sending documents in response to a query.
- The VHIE will be moving to the eHealth Exchange Hub, providing a centralized connection to all eHealth Exchange participants.
- The VA HIE Gateway will be migrating to a new platform in Winter 2019.

PA eHealth Exchange Hospital Quality Improvement Program MA ED OUD Reporting

As part of the reporting requirements under the Hospital Quality Improvement Program for Opioid Use Disorder from the Pennsylvania Department of Human Services, hospital emergency departments are required to meet performance measures for the warm hand-offs of Medical Assistance patients seen in an emergency setting for Opioid Use Disorder. As of June 30, 2019, the following hospital emergency departments are now live and meeting the reporting requirements through their connection to P3N with KeyHIE:
